The charity runs climbing sessions at The Foundry Climbing Centre, Sheffield. Sessions are always supervised by The Foundry's instructors, and The Foundry's procedures are followed, including safety procedures for climbing, and The Foundry's recording of parent/guardian consent for children and for adults under guardianship.

THE OBJECT OF THE CIO IS THE PROMOTION OF COMMUNITY PARTICIPATION IN HEALTHY RECREATION IN PARTICULAR BY THE PROVISION OF FACILITIES FOR PARTICIPATING IN CLIMBING ACTIVITIES FOR THE RESIDENTS OF SHEFFIELD AND SURROUNDING AREAS.

In more detail, the objects of the charity are:

1. To provide opportunities for children, young people and adults

with a wide range of disabilities to access and enjoy rock climbing and mountaineering and be visible and included in the climbing community in Sheffield.

- 2. To increase levels of participation of children, young people and adults with a wide range of disabilities in rock climbing and mountaineering, in order to:
- Improve their physical development, health and wellbeing;
- Improve their self-image and self-esteem; and
- Develop their confidence and ability to communicate and interact with other people.
- 3. To develop a strong and sustainable network of instructors with the qualifications, skills and experience needed to confidently help children, young people and adults with a wide range of disabilities to access and enjoy rock climbing and mountaineering.

Trustees acted throughout the period to provide public benefit:

PROMOTING COMMUNITY PARTICIPATION IN HEALTHY RECREATION IN PARTICULAR BY THE PROVISION OF FACILITIES FOR PARTICIPATING IN CLIMBING ACTIVITIES FOR THE RESIDENTS OF SHEFFIELD AND SURROUNDING AREAS.

A climbing club was established, providing opportunities for children, young people and adults with a wide range of disabilities to access and enjoy climbing in Sheffield.

Operating at The Foundry Climbing Centre, the club enabled disabled climbers to be visible and included in the climbing community in Sheffield. Involvement of volunteers from the climbing community, and development of experience amongst volunteers and instructors, promoted climbing as a recreation for children, young people and adults with disabilities.

Taster sessions were held, providing opportunities for disabled climbers to try climbing, many of whom subsequently climbed with the club.

Volunteers are essential to the operation of climbing activities. Many of the charity's climbers require assistance of one or two side-climbers with belayers for climber and side-climber(s), and person to support upward lift with pulley.

Whilst instructors are employed by The Foundry and are paid, volunteers are unpaid, keeping cost of sessions affordable.

Friendly interactions with volunteers make climbing sessions fun for many climbers, while the involvement of most volunteers in various aspects of climbing is a major contributor to the visibility of disabled climbers in the climbing community.

Achievements and performance

Summary of the main achievements of the charity during the year

After constitution as a charity, Climbing for All Sheffield established a regular climbing club, which operated during term time throughout the period. Around 36 sessions were held during the school year from September 2016 to July 2017.

A small group of climbers attended weekly sessions up to July 2016. The decision was made to hold 'taster events' to create more opportunities to experience climbing, and the first of these was held 17th September 2016.

The first taster session was attended by 13 climbers, of which 11 were new; 4 of these went on to climb regularly with the club.

After Christmas 2016, twice weekly sessions were held, on Monday evenings and Saturday afternoons. In the Spring term, there were 16 sessions, and between 5 and 7 climbers were present at each, there being 6 climbers in total.

A further taster session on 26th November 2016 was also attended by 13 climbers, of which 12 were new. 7 of these went on to climb with the club (and 3 of these progressed to readiness to climb with mainstream groups). A bespoke group was planned for a further 3, who required a quieter setting.

A further 12 club sessions were held in the summer term, up to July 2017.

The trustees are very pleased that both children and adults have been represented at the club, with a variety of physical, cognitive and sensory impairments and/or autism. The club has provided opportunities for families to climb together, with non-disabled siblings or children getting an opportunity to climb alongside disabled family members.

A variety of systems have been developed and signed-off to assist climbers, always with the top-rope mandated by The Foundry and providing safety via approved standard belay technique. Kit has been donated by sponsors or purchased with donations, and has been labelled and stored, with regular checks made on its condition.

Around 16 volunteers have been involved at sessions, plus members of the committee.

In addition to climbing sessions, the Christmas lecture stimulated interest in climbing for all, with many attending from the climbing community and beyond to hear an inspirational speaker describe his experiences as a disabled climber.

Financial review

Brief statement of the charity's policy on reserves

Our reserves position: at end of FY (July 2017), unrestricted funds stood at £791.

Annual expenditure FY17 (July 2016 – July 2017) amounted to £3007, thus the ratio of reserves to annual expenditure was 26%.

Expenditure is committed 2 months in advance (hire of instructors). The minimum ratio of reserves to annual expenditure required for continuity of operation of climbing clubs is thus approximately 17%.

Reports for subsequent years will record that the increasing profile of the charity has led to further donations and successful fundraising. The Board will maintain reserves at 33% of annual expenditure moving forward, thereby giving certainty of operation for approximately 4-month periods.

In addition, the charity may seek grant funding to allow an expansion of operations.

Policy on reserves will be reviewed alongside operational planning and financial review.

The attached financial report sets out key income and expenditure headlines.

Principle costs are for instructors to lead climbing sessions, at £2,610 in FY17. Income from sessions was only £646; while it may be possible to collect session payments more efficiently, the charity remains committed to providing climbing opportunities to all, regardless of their ability to pay.

Generous donations of kit from sponsors, notably DMM Climbing, allowed the club to avoid capital expenditure during the start-up year. Note that equipment items are not listed as assets because monetary transfer of equipment would not be feasible.

Principle income was from fundraising and donations, at £1,388. In addition, the Christmas lecture raised £550, as well as providing a highly entertaining and informative evening for the wider climbing community.
